Setting the Stage: Why Health Justice Partnerships Matter Now & Creating a Shared Language

Description

This plenary session will set the stage for the conference by exploring the growing global movement toward Health Justice Partnerships (HJPs) as an integrated approach to addressing the social, legal, and structural determinants of health.

Plenary speakers will provide a high-level overview of what HJPs are and why they are needed now more than ever. They will examine how HJPs are being implemented across jurisdictions, drawing on examples from countries including Australia, the United Kingdom, the United States, and Canada. The plenary will consider how collaborative, interdisciplinary responses can reduce systemic barriers experienced by marginalized populations and contribute to better health, social, and justice outcomes for all.

The discussion will also situate HJPs within broader national and international policy frameworks and commitments, including universal health coverage, human rights-based approaches to health, access to justice initiatives, Indigenous rights and reconciliation efforts, and the United Nations Sustainable Development Goals (SDGs). Particular attention will be given to the ways HJPs advance commitments to equity, prevention, early intervention, and person-centred care and justice.

The session will provide participants with a shared understanding of the strategic importance of HJPs and the opportunities for cross-sector collaboration, policy innovation, and systems change. It will also establish a foundation for the conversations and knowledge exchange that will continue throughout the conference.

By grounding the conference in a shared understanding of both the urgency and the opportunity of this work, the plenary will inspire participants to think boldly about collaboration, innovation, and collective impact in advancing health justice.

Teaching & Embedding Health Justice in Medical, Healthcare & Legal Education

Description

This session brings together three educators and practitioners who are actively integrating health justice content into medical, healthcare, and legal education. Speakers will share their approach to embedding health justice content in the curriculum, the lessons they've learned along the way, and practical strategies for others looking to include health justice in their own curricula.

This session will explore:

- The approaches speakers have developed, how they came about, and what implementation looked like in practice
- The case for health justice education - why this work matters, why the moment is right, and why their particular approaches were chosen
- Strategies for gaining institutional buy-in and successfully integrating health justice content into existing curricula
- Recommendations and practical takeaways for educators and practitioners ready to take next steps

Equity, Inclusion, & Priority Populations

Description

This panel will explore the histories of community-led health justice activism that have shaped, and often predated, what are now called “health justice partnerships”. Drawing on the expertise of people with lived experience, elders, activists, and community leaders, the session will examine how marginalized communities have built models of care, legal support, policy change, and resistance in response to systemic inequities across healthcare, legal, social service, and carceral systems.

Rather than treating HJPs as a new innovation, the panel will ask what current practitioners can learn from long-standing movements, including HIV/AIDS activism, harm reduction, MAD organizing, and more. Panelists will share lessons learned, strategies that worked, harms to avoid, and principles for building partnerships that remain accountable to the communities they aim to serve.

Description

Building Evaluation & Research Capacity for Advancing Health Justice Partnerships

Description

In this practical workshop, we will canvass the different ways that HJPs can be researched and/or evaluated based on approaches taken in several countries. Evaluation experts will provide perspectives on suitable research methodologies and data collection methods. What evidence should we be collecting? How do we get started? What does a meaningful but realistic evaluation framework look like? What can we learn from existing models?

This session intends to lay the groundwork for both feasible small scale participatory-based and other empirical evaluations of partnerships by learning lessons from healthcare and other disciplines, as well as considering more ambitious and resource-intensive research studies on the impact of these partnerships.
